In September 2018, Investindustrial and The Carlyle Group announced their intention to create a global high-end interior design group, initially bringing together three complementary companies with strong individual identities and long design heritage: B&B Italia Group in furniture, Flos and Louis Poulsen in lighting. Since then, in line with this vision, a strong central leadership team has been appointed to guarantee coordination and unlock the benefits of larger scale and deeper knowhow shared across the combined organizations.
